4. Old Business

a. Pickleball Surfacing

b. Project Updates

i. Champion Pool

(Carleen) town of Rosman proposed to the Board of Commissioners to take over Champion park pending a USDA grant of \$50k is awarded to the Town to do repairs to the pool in the total amount of \$100k. The Board of Commissioners approved this motion to deed over the park to the town of Rosman pending the receipt of the grant.

ii. Silvermont Trail

(Carleen) New boardwalk has been installed temporary due to the current weather conditions.

iii. Bench Installation

(Carleen) Waiting on the concrete to be delivered and weather to improve.

Strategic Plan Update

(Carleen) Survey, focus groups, public meeting and the consultant visits to parks are complete. The consultant is currently working with the county staff and city staff to understand the operations of the parks and recreation. Then they will incorporate all of this information into a final draft plan for the next 5 years. This will be presented to the City Council and County Commissioners in hopes that they will adopt the suggested plan.
